

#### Against Technology? Heidegger and Daoism

It is often argued that Heidegger is a profoundly provincial thinker who is against technology and all its implications. The same is often said about classical Daoism (Laozi and Zhuangzi). This paper will challenge such facile assumptions and explain the complexities of the actual positions of Heidegger and the Daoists. It will then search for similarities in their approach, and argue for ways in which their understanding of how to deal with technology can aid us in our increasingly technological world. I will argue that although on the surface Heidegger and Daoism seem strongly anti-technology, and their preferred ways of living are highly localised and rural, in reality their ways of thinking can guide us in our understanding of our possible responses to ethical issues arising from technology and its increased prominence. Through notions such as Heidegger's Gelassenheit and the Daoist ziran and wuwei, it will be argued that a productive attitude change is necessary if we are to successfully manage and deal with ethical issues arising out of our use of technology.

#### Why people are having less children: Insights from mismatch research

Although the ultra-low fertility rates found in Singapore and many other modern nations have been attributed to prohibitively high financial costs of having children, there may be other key elements of modern environments that are influencing people's reproductive attitudes and behaviors. I briefly present the life history mismatch framework and results from recent studies suggesting that it's not just all about a lack of money.

#### The Political Vision of Wenzi: A Daoist Model of Good Government

This presentation outlines key dimensions of the political vision of Wenzi (a.k.a. Wen-tzu), a Daoist (a.k.a. Taoist) text that teaches how man(kind) has lost its way and governments have become corrupted by losing the Way (Dao). Neither anarchic nor reactionary, Wenzi's political proposals reflect a view that is seemingly more pragmatic compared to some of the early Daoist classics. Criticizing bad governance as a cause and consequence of ignorance, violence, and greed, Wenzi counters by proposing a political system featuring order, peace, contentment, the rule of law, and a system of public administration that is effective and efficient. In this idyllic scenario, people enjoy sustenance, nonviolence, stress-free longevity, and unity/harmony under a government and leaders who are fair, flexible, and unobtrusive. While idealistic on the one hand, Wenzi's political thought nevertheless delivers a message of value to ordinary people and intellectuals today on how a good government might function.

Alongside outward investments, infrastructure projects, and territorial claims, Chinese diasporas have become increasingly important in Global China's strategies for geopolitical ascendancy. These homeland-diaspora ties, however, push Chinese migrants to the center of Sino-West tensions and render them victims of the rising Sinophobic sentiment and anti-China discrimination in host countries.



Drawing on interviews and ethnographic data, collected in two years of fieldwork in China and Europe, this book project argues that China's increasingly assertive diaspora policies do not constitute a uniform or unequivocal expansionist endeavor. Instead, Chinese diaspora politics is equally shaped by the agentic maneuvers of Chinese emigrants and influenced by internal conflicts within the Chinese bureaucracy and diaspora communities. I introduce the concept of "transborder state-building" to theorize nation-states' systematic efforts to develop logistical and institutional capacities for governing their citizens overseas. Prior research in political sociology has often adhered to the Westphalian assumption that nation-states are territorially bound, confining their focus within state borders. By analyzing how China exerts control and delivers civil services abroad, this book project expands the scope of research on state-building to encompass cross-border domains and delves into diaspora governance as an overseas manifestation of conventional state-citizen relations.

Yet, state-diaspora relations have not been characterized by China's absolute rule or top-down governance. This book unveils how China's transborder state-building is both catalyzed and conditioned by three grassroots mechanisms: Chinese street-level officials' bureaucratic zeal, diaspora elites' symbolic remittances, and ordinary emigrants' stratified ties. While these bottom-up processes may sometimes align with the project of Global China, they can also disrupt this project due to the pragmatic and even irrational motivations of grassroots actors. Instead of assuming an asymmetric relationship between emigration countries with weaker standings and immigration countries with hegemonic positions, I demonstrate how an aspiring homeland state aims to challenge the established world order through diaspora strategies and how migrants capitalize on this ambitious grand plan to negotiate their transborder belonging.



### Faculty Spotlight



Yasmin Ortiga Assistant Professor of Sociology; Lee Kong Chian Fellow

How do people move across borders? In answering this question, Yasmin's research argues that in the case of labor migrants, movement often depends on the question of skill - or how employers, governments and even migrants themselves define, certify, and assess people's capabilities. To date, migration scholars have largely treated skill as an individual resource — a form of "human capital" to be maximised, or a part of migrants' labor power, often exploited and devalued. For more than a decade, Yasmin's research has shown how different notions of skill also shape people's movements, creating global pathways for the migration of some, while justifying the immobility of others. Rather than simply trace where people bring their skills, her work has raised the important question of how these skills are produced and redefined in the migration process.

Currently, Yasmin is developing two projects on how broader skills regimes shape the migration trajectories of two types of migrants. The first project investigates how temporary destinations like Singapore become part of healthcare workers' migration trajectories. Specifically, she seeks to determine how state institutions, employers and professional associations channel migrant nurses and doctors into the country, while eventually pushing them out to others.

Meanwhile, the second project examines the multinational movements of agricultural workers. With her collaborators, Yasmin aims to investigate how agricultural industries in places like Australia and New Zealand increasingly require "skilled" workers, encouraging aspiring migrants to move through multiple countries in order to accumulate the experience needed for their desired destinations. They compare the experiences of two groups of Filipino farmers: 1) vegetable farmers who move through Japan to gain the work experience for farming positions in Australia, and 2) dairy farm workers who seek experience in the UAE to qualify for jobs in New Zealand. While migration scholars and policymakers have long debated how best to attract skilled workers, few investigate how such movement is shaped by skills requirements, standards, and qualifications. This is an issue that has been otherwise ignored in both migration scholarship and labor policy.

## Faculty Spotlight



Patrick Quinton-Brown
Assistant Professor of Political Science

Patrick's research interests cover theories of international relations and global governance; international organisations and institutions; interpretive and postcolonial approaches; and the role of the Global South in the normative and political development of international society. So far he has been primarily concerned with non-Western contestations of Western-dominated historical orders, including through the Non-Aligned Movement and related groups in and around the United Nations.

His first book, *Intervention before Interventionism:* A Global Genealogy (forthcoming with Oxford University Press in April 2024), reflects on these issues in terms of the present crisis of liberal interventionism. How are we to make sense of re-organisations of sovereignty and intervention in the norms and rules of statespeople? Recently the dominant way of thinking about these ideas has been through the lens of cosmopolitan or liberal-solidarist duties, including the Responsibility to Protect. Yet it seems doubtful that this framework is still capable of posing the right questions or generating the right sorts of answers. The book offers a new approach that provincializes the conventional debate and de-naturalises what it takes as universal or given. It does so through a genealogy of the intervention concept and a recovery of shared intergovernmental practices of Asia, Africa, and Latin America.

He has recently completed articles that relate to post-Western-centric theorising and the uses of history and critical theory in international relations and its study. One, published in *Review of International Studies*, provides a critique of contemporary academic debate on humanitarian intervention. Another, published in *International Affairs* and co-authored with Margaret MacMillan, examines the ways in which historical narratives are used in world politics. And a third, published in *International Relations*, explores competing strains of internationalism through a discursive analysis of Cuba's intervention in Angola, 1975.

Two article manuscripts are in progress. The first proposes a novel theory of the principle of non-intervention by situating the international political thought of Giuseppe Mazzini in the institutionalized practices of the Asian-African Conference of 1955 hosted in Bandung, Indonesia, which introduced anti-colonialism and anti-racism as constitutive principles of evolving global order. The second has to do with methodology and notions of legitimacy, value conflict, and the decolonization of the so-called English School of International Relations. His next book project will analyse models of peaceful coexistence and the pursuit of international law and justice in conditions of multipolarity and Great Power competition.
